As a side note, I am still working with Lisa Martin on having a representative from the Department of Consumer Protection to also be at the August meeting, I think the consensus from our last meeting was that it would be good to have DCP with us for discussion around their guidelines/policy and how that “jives” with DSS waiver policy.

Lastly, I am working on **rebuilding my PC distribution list** which I lost a few weeks ago due to an outlook glitch. I’ve done my best to recreate, but might be missing a couple of names. I ask that you pls expand the “to” to see all names on the distribution list and let me know if I have missed anyone in your organization. Pls. share with others as appropriate.
